Reference: Advertisement Notice No. 01 and 02 of 2013 dated 12.03.2013 and 03 of 2013 dated 26.06.2013.

WRITTEN TEST NOTICE

Whereas, written test was scheduled on 9th July, 2014 for Fireman/Fireman driver and 10th July 2014 for Foreman/Junior Electrician/Painter/Vulcanizer/Plumber/Sub Officer (Steno Typist) and Leading Fireman - M (Junior Assistant) at Srinagar, Jammu and Karigal covering candidates for the districts of Srinagar and Jammu on 21 and 22 of July 2014.

Whereas, the written test could not be conducted on the scheduled dates and was accordingly postponed;
Whereas, after re-verification it was found that some of the candidates were inadvertently included in the list of qualified candidates of 1st phase of tests besides some of the qualified candidates in the 1st phase were inadvertently not reflected in the notices published in leading daily newspapers of the State and hoisted on departmental website.

As such, notification No. 01 and 02 were issued and published in leading daily newspapers of the State and hoisted on departmental website by the Chairman DRB and the candidates, if any, having any grievance were given chance to appeal before the Members of the Departmental Board and Jammu on 21 and 22 of July 2014.

Whereas, pursuant to notification No. 02, Notification No. 03 was issued vide No. NODR&F&ES/Rec/2013/3910-3917 dated 28.07.2014.

Whereas, in terms of advertisement notices No. 01 & 02 of 2013 dated 12.03.2013 it was made clear that call letters shall not be issued individually, however, the Departmental Recruitment Board shall give wide publicity through print and electronic media, departmental Website (www.kfireandemergency.org) about the venues, dates of the interview of the eligible candidates besides no claim of being unaware of the dates/schedule for interview shall be entertained.

Whereas in order to avoid further inordinate delay by dispatching the interview notices individually, this notification is hoisted on the departmental website and published in the leading newspapers of the State.

There will be no written test for the post of Cook, Barber and Sweeper. No TADA will be paid to any of the candidate for appearing in the written test.
