Srinagar, Aug 29: The 3rd National Dragon Boat Race Championship being organized by the J&K State Sports Council will begin at Nehru Park, here on Saturday. An official statement said the event will culminate on September 2 which will be participated in by around 300 participants and officials from different states of the country. "The inauguration of the mega event will be held on 30th of August at 10.00 a.m at Water Sports Centre Nehru Park by Sports Minister Raman Balla who will be the chief guest at the function. Competitions in 200 mtr, 500 mtr and 2000 mtr event in men, women and mixed categories will

be held during the championship", it said. Meanwhile, a local player on Friday accused the selection committee set up for selecting JK team of indulging in favoritism. "I stood first in the trials held at Nehru Park a few days back recording the best timing but was surprised to find that the selection committee has selected blue eyed candidates", said Nilofar Nabi, a local Dragon boat player. "The selection committee selected their near and dear ones and left out deserving players. They even completely changed the original selection list and have come up with an altogether new list," she alleged.

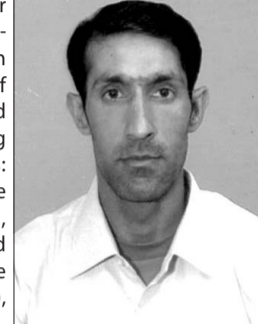
